#### **Definitions and interpretation**

1. In this privacy policy, the following definitions are used:

Data	collectively all information that you submit to NWSPK Ltd via the Website. This definition incorporates, where applicable, the definitions provided in the Data Protection Laws;
Cookies	a small text file placed on your computer by this Website when you visit certain parts of the Website and /or when you use certain features of the Website. Details of the cookies used by this Website are set out in the clause below ( <b>Cookies</b> );
Data Protection Laws	any applicable law relating to the processing of personal Data, including but not limited to the GDPR, and any national implementing and supplementary laws, regulations and secondary legislation;
GDPR	the UK General Data Protection Regulation;

- 2. In this privacy policy, unless the context requires a different interpretation:
  - a. the singular includes the plural and vice versa;
  - b. references to sub-clauses, clauses, schedules or appendices are to sub-clauses, clauses, schedules or appendices of this privacy policy;
  - c. a reference to a person includes firms, companies, government entities, trusts and partnerships;
  - d. "including" is understood to mean "including without limitation";
  - e. reference to any statutory provision includes any modification or amendment of it;
  - f. the headings and sub-headings do not form part of this privacy policy.

#### Scope of this privacy policy

- 3. This privacy policy applies only to the actions of NWSPK Ltd and Users with respect to this Website. It does not extend to any websites that can be accessed from this Website including, but not limited to, any links we may provide to social media websites.

- 10. We may share your Data with the following groups of people for the following reasons:

#### **Keeping Data secure**

- 11. We will use technical and organisational measures to safeguard your Data, for example:
  - **a.** access to your account is controlled by a password and a user name that is unique to you.
  - **b.** we store your Data on secure servers.

#### **Data retention**

## Your rights
